## Self-Sabotage

Are you having trouble achieving all your goals? If you are not doing some of the things you know you should be doing, you may be a victim of self-sabotage. Here are some examples *and* ways to effect change.

**Problem:** Thinking and speaking a lot about what is going wrong can make you feel dissatisfied and dampen your sense of purpose and ambition. Start to notice how

often you speak about things that are not working.

Action: Instead ask yourself each morning, "What is going right in my life and my business?" Begin to notice all the things, no matter how small, that are working well. Keep a journal and write them down each day. Program your mind to focus most on the positive things in your life!

**Problem:** Do you worry a lot about the future and what might happen? Are you thinking about your fears so much that you are paralyzed and take no action because of what might or could occur?

Action: In previous columns we have discussed F.E.A.R. as an acronym for "False Expectations Appearing Real." It is time to focus on the present. We can't control or predict the future or other people's behavior. We can control our own actions, right here, right now. Ask yourself "What is the worst thing that could happen?" Then, let go and know that it isn't in your hands to control the future and rarely does the scenario we create in our mind actually occur. Use the Serenity Prayer as your guide. Write down the things you cannot change, the things you want the courage to change, and accept your guiding spirit as the ultimate guide. Relax and trust that the Universe will take care of you. It always does!



**Problem:** Do you forget all your accomplishments and lack pride in who you are and what you have accomplished? If you fret about the past or your lack of success or lack of goal achievement, then you are constantly reminding yourself of your imperfections. When you criticize yourself or can't accept compliments, you aren't allowing yourself to love and appreciate YOU!

Action: You can choose to notice what you do that is good; the things you are proud of, no matter how small it may seem. Each day keep a log of things for which you are grateful. When you hear your "inner voice" focusing on what you have not done well, turn down the volume and turn up the volume to hear the voice that knows the TRUTH about who you are and how you add value to the world! Acknowledge and compliment yourself for at least five things each day that you did well and you feel good about. Highlight your small successes and accept compliments from others. Take pride in and gain positive momentum from both your small and big accomplishments each and every day!

## A Trifecta at Riverfest Park

Congratulations to the shakers and movers of the Chamber of Commerce for a successful concert event June 26 with Tracy Lawrence. It's pretty impressive what can happen when all the right elements come together to create a perfect storm. Good entertainers, vendors, rain-free weather, and an army of dedicated volunteers coming together at Riverfest Park will do the trick.

So if we had one successful weekend at Riverfest Park, why stop there? How about having another one on July 4 and, heck, while we're at it, lets do a third event on July 8-10.

On July 4, the City is sponsoring the second (looks like a tradition getting started) annual 4th of July Community Picnic and Fireworks show. Hopefully, you were not one of the would-be visitors we had to turn away last year because we maxed out the available parking. So here's a hint for this year; don't wait late in the evening to come down to the Park. The fun starts at 6PM with vendors galore, offering you typical backyard picnic fare including

burgers, hot dogs, BBQ, desserts, lemonade, etc. And while you're eating and waiting for the sun to set, you'll be entertained by live music and free fun for the kids. But you can't enjoy it all if you wait until the last minute. Avoid the hassle of cleaning up after your own back yard cookout and join your neighbors for a good old-fashioned community picnic.

After you recover from the oohs and ahhhs of the July 4 fireworks show, come on back to the Park on July 8-10 for the annual De Soto Days Festival. The annual 3-day event will be bigger and better, offering rides and entertainment from a new carnival company and such new twists as a petting zoo complete with—get this—a kangaroo and camel. That's right, check out these new attractions and a full schedule of food and entertainment for the entire family.

It's all happening down at the Park.

## **EDC Update**

The EDC recently received the Annual Zip Code Demographic Report from the County Economic Research Institute. Below are highlights from the report relating to De Soto:



Economic Development Council

- De Soto's population is now 5,737, an increase of 50 from last year.
- Family households decreased by 22 while non-family (single resident) households increased by 28.
- The annual growth rate for households decreased by .15% meaning we are growing slightly slower than we were from the 2008 statistics.
- The average value of homes in De Soto is \$170,317 and is a \$3,345 decline from 2008.
- The average rent in De Soto is \$710, which is \$11 less than last year.
- With regards to population age statistics, De Soto realized slight increases in the 0-19 age category. Slight declines were noted in 20-24, 25-44 and 45-64 age categories. Population ages 65 to 85 and over were relatively flat.
- De Soto's median age did not change this year and is 35.3. In the past, the trend demonstrated that De Soto was slowly increasing in median age.
- De Soto's average household income is \$81,585 compared to \$83,443 in 2008. Note: Even with the decline, De Soto had a 1% increase above the US average. This means that while De Soto's household income declined, we are faring better than other US communities.

Roughly 42% of households earn \$50,000 - \$99,000 per year.
Roughly 9.5% of households earn less than \$25,000 per year.
All areas noted a small decline in numbers with the exception of \$100,000 - \$149,000 households, which realized a 1.1% increase in this category.

The report also provides the annual dollar amount we spend as a community on goods and services such as: food & beverages, housing expenses, apparel, transportation, medical care, entertainment and education. In every area, the population is spending less than they did a year ago. This was also common in other Johnson County zip codes.

While the report showed declines in various areas, this is a normal trend given the economy. This should not negate the growth De Soto realized in the household earning statistics and how well De Soto compares amongst other US communities. Another area of importance is that the median age remained flat and that we are seeing an increase in the younger demographic based on the population ages from the report.
